MINUTES TOWN OF LOGANSPORT December 8, 2015

The regular meeting of the Logansport Town Council was held Tuesday, December 8, 2015 at 5:00 p.m. in the Council Chamber of Logansport Town Hall with Mayor Katherine Freeman presiding. Council members present: Norman Arbuckle, Judge Cordray, Martha Guillotte, June Hooper, and Edith Williams. Absent: None. Eleven guests were in attendance.

The meeting was opened with the Lord's Prayer and the Pledge of Allegiance.

With a motion from Mr. Cordray and second from Mrs. Guillotte the November minutes were approved as written. All ayes.

The monthly bills were approved with a motion from Mr. Arbuckle and second from Mrs. Hooper. All ayes.

The Mayor called for public comments. Jean Border asked if a red light was going to be placed at Main/ Hwy 84 and Marshall Road/Hwy 764 intersection. She was informed that no plans have been finalized for a light. It is a possibility that the light at Main and 4th Street could be moved to that location, but adding an additional light without removing the one at Main and 4th would make the lights too close together, therefore the DOTD will not approve it. There were no more questions or public comments.

A public hearing to discuss the 2016 proposed budget was opened with a motion from Mrs. Guillotte and second from Mr. Cordray. There were no questions or comments and the meeting closed with a motion from Mrs. Hooper and second from Mr. Cordray.

With a motion from Mr. Cordray and second from Mr. Arbuckle the 2016 budget was adopted. All ayes.

With a motion from Mrs. Hooper and second from Mrs. Guillotte, the 2015 budget amendments were approved. All ayes.

The 2016 liability insurance policy was approved with a motion from Mrs. Hooper and second from Mrs. Williams. All ayes.


A bid from Baldwin Tree Service in the amount of \$4500 to cut and remove trees on the riverfront between the 2 bridges was approved with a motion from Mr. Cordray and second from Mr. Arbuckle. All ayes.

With a motion from Mr. Arbuckle and second from Mrs. Hooper a policy was approved outlining community service in lieu of cash fine payments. All ayes.

With a motion from Mr. Cordray and second from Mr. Arbuckle, it was approved to take NO partial payments on fines. All ayes.

Kevin Bryant, Code Enforcement Officer, urged everyone in attendance to take pride in our Town and report any property needing attention so that he can address it with the property owner.

Mrs. Guillotte reported that only \$1005.50 was collected in fines for the month of November, but she had no numbers from the sub-station regarding number of calls or citations issued.
