

**TOWN OF LOGANSPOUR
SPECIAL COUNCIL MEETING
MINUTES
February 2, 2015**

A special meeting of the Town Council for the Town of Logansport was called to order Monday, February 2, 2015 at 5:30 p.m. in the Council Chamber with Mayor Katherine Freeman presiding. Members present: Norman Arbuckle, Judge Cordray, and Edith Williams. Absent: Martha Guillotte. A quorum was present.

The purpose of the meeting was to call a special election and make an appointment for the unexpired term of former council member, Dale Morvan, pursuant to the provisions of Louisiana Revised Statute 18:602.

With a motion from Mr. Cordray and second from Mr. Arbuckle it was approved to appoint June Hooper, who was the next person with the highest votes at the last election of mayor and council, to fill the vacancy until a special election can be called. All ayes, one absent.

A resolution was adopted with a motion from Mrs. Williams and second from Mr. Arbuckle to call for a special primary election to be held October 24, 2015, a general election (if necessary) to be held November 21, 2015, with qualifying period for candidates September 8-10, 2015. All ayes, one absent.

With no further business to discuss, the meeting adjourned with a motion from Mr. Arbuckle and second from Mrs. Williams. All ayes, one absent.

MINUTES
February 10, 2015

The regular meeting of the Logansport Town Council was held Tuesday, February 10, 2015, in the Council Chamber of Logansport Town Hall with Mayor Katherine Freeman presiding. Council members present: Norman Arbuckle, Judge Cordray, Martha Guillotte, June Hooper and Edith Williams. Absent: None. Five guests were in attendance.

The meeting opened with the Lord's Prayer and the Pledge of Allegiance.

With a motion from Mr. Arbuckle and second from Mr. Cordray the January minutes were approved as written. All ayes.

General fund and Utility fund bills were approved with a motion from Mr. Arbuckle and second from Mrs. Guillotte. All ayes.

Mayor Freeman introduced Sgt Carol Richardson, Captain Jason Richardson, and new Deputy Lester McDaniel. They were here to address any questions regarding traffic patrol and any other problems that would be handled through the Logansport sub-station.

There was no old or new business to discuss.

Mr. Cordray reported on the meeting on the riverfront with representatives from the SRA, DeSoto Police Jury, as well as local representatives to discuss the construction of a floating dock somewhere along the riverfront park area. He stated depending on how large a dock area constructed, the cost would probably run between \$25,000-\$35,000. Money will be raised through donations to pay for the dock.

Mr. Cordray also reported on various requests for street repairs and stated that 2nd Street at the corner of Elm across from the sub-station had eroded badly and definitely needed repairing. Also, he had several calls regarding the potholes on 7th Street from Hwy 84 all the way to Gum Street.

Mrs. Guillotte gave the Police report, stating there were 140 calls with 31 citations and \$3,514 collected in fines for the month of January.

Mr. Arbuckle reported the Annual Sand Bass Tourney is on go for Saturday, March 14th with the fish fry on Friday, March 13th.

Mrs. Hooper was welcomed as the new council member replacing Dale Morvan. Her appointment was approved by the Secretary of State and she was sworn in prior to council meeting.

With no further business to discuss, the meeting adjourned with a motion from Mr. Cordray and second from Mr. Arbuckle.
