The regular monthly meeting of the Logansport Town Council was held Tuesday, December 13, 2016 at 6A:00 p.m. in the Council Chamber of Logansport Town Hall with Mayor Katherine Freeman presiding. Council members present: Norman Arbuckle, Judge Cordray , Martha Guillotte, and Edith Williams. Absent: June Hooper. A quorum was present. Three guests were in attendance.

The meeting was opened with the Lord's Prayer and the Pledge of Allegiance.

With a motion from Mr. Arbuckle and second from Mrs. Williams a public hearing was opened to discuss the 2017 proposed budget. There were no questions or comments from the public and the meeting adjourned with a motion from Mrs. Williams and second from Mr. Arbuckle. All ayes, one absent.

The November minutes were approved as written with a motion from Mr. Cordray and second from Mr. Arbuckle. All ayes, one absent.

The monthly bills were approved as presented with a motion from Mrs. Williams and second from Mr. Arbuckle. All ayes, one absent.

The 2017 proposed budget was approved with a motion from Mr. Cordray and second from Mrs. Guillotte. All ayes, one absent.

Renewal of the Liability Insurance Policy was approved with a motion from Mr. Cordray and second from Mr. Arbuckle. All ayes, one absent.

The 2016 Budget amendments were approved with a motion from Mr. Arbuckle and second by Mrs. Williams. All ayes, one absent.

A lease amendment to release the old baseball field back to the DeSoto Parish School Board was approved with a motion from Mr. Cordray and second from Mr. Arbuckle. All ayes, one absent.

Mrs. Guillotte reported the sub-station issued 18 citations and made 12 arrests during the month of November. A total of \$2,252 was collected in fines.

With no further business to discuss, the meeting adjourned with a motion from Mr. Cordray and second from Mr. Arbuckle. All ayes.
