- 593 AN ORDINANCE TO PROVIDE THAT ALL PREMISES AND VACANT LOTS WITHIN THE CORPORATE LIMITS OF THE TOWN OF LOGANSPORT WILL BE KEPT FREE OF TALL GRASS, WEEDS, OR OTHER NOXIOUS GROWTHS AND FREE OF GARBAGE, TRASH, LEAVES, DEBRIS,
